PRODUCT NAME : **RED GINGER EXTRACT-PC** (COSMETIC)

This product is extracted from red ginger, the rhizome of *Zingiber officinale* var. Rubra, with aqueous ethanol. It guarantees minimum 6.0% [6]-gingerol and [6]-shogaol, and 1.5% tannin. A peak of 3R,5S-[6]-gingerdiol is observed in HPLC chromatogram.
