Officially certified for "Indonesian Halal"! 174 Food and Cosmetic Ingredients Now Ready for Export!

Oryza Oil & Fat Chemical Co., Ltd. is pleased to announce that a total of 174 of our food and cosmetic ingredients are now officially compliant with Indonesian Halal standards, making them officially available for export to Indonesia.

Keeping in mind the growing Muslim population and the expanding Halal economy, we began acquiring Halal certifications in 2011. As of 2025, we have achieved certification for 174 of our products. We have already been expanding product exports, primarily to Malaysia and Taiwan, where our products are already export-ready.

Currently, we obtain Halal certification through the NPO Nippon Asia Halal Association (NAHA). In February 2025, NAHA achieved mutual recognition with Indonesia's Halal Product Assurance Organizing Agency (BPJPH). This significant development means that all 174 of our products that have obtained Halal certification through NAHA are now officially cleared for export to Indonesia, in addition to countries like Malaysia and Taiwan.

■ Current Status of Indonesian Halal

Indonesia operates its own government-mandated Halal certification system. Specifically, Government Regulation No. 39 of 2021 concerning the Implementation of Halal Product Assurance, enacted on February 2, 2021, set October 17, 2024, as the deadline for obtaining and displaying Halal certification for food products circulated in Indonesia, including imported goods. Consequently, preparations for Halal certification of imported food products from Japan were underway. However, Government Regulation No. 42 of 2024 (an amendment to Government Regulation No. 39 of 2021), enacted on October 18, 2024, stipulates that the deadline for mandatory Halal certification for imported food products will be extended by up to October 17, 2026. (For cosmetics, the deadline is also October 17, 2026.)

There are two main methods for obtaining valid Halal certification in Indonesia: applying directly to BPJPH or utilizing an overseas Halal certification body (LHLN). In both cases, the application must be made by an Indonesian importer or an authorized agent. Specifically, after an export contract from Japan is established, registration documents such as the Halal certificate are sent to the Indonesian importer or authorized agent.
